
5. Throughout the time period from 1950 to 2006, I have used the road myself for county road maintenance and travel in and through the area.

6. Throughout the time period described in the previous paragraph, I have observed other vehicles from the general public using the road at various times for the uses described in the previous paragraph plus livestock operations.





5. Throughout the time period from 1960 to 2006, I have used the road myself for livestock operations and hunting.




