Section 932 (repealed October 21, 1976, with proviso recognizing the validity of rights-of-way already established)) was accepted for and on behalf of the State of Utah and its political subdivision Box Elder County as it pertains to the highway located in Box Elder County known as Salt Wells Road; County Road Number: 135; State Geographic Information Database (SGID) Road Identification Number: RD020044. Total road length is 19.48 miles more or less.

This Amended Acknowledgment and Amended Notice of Acknowledgment supersedes the information contained in the Acknowledgment recorded at Ent 238505, Bk 988, Beg Pg 609.

The reason for this Amended Acknowledgment and Amended Notice of Acknowledgment includes, but is not limited to, the fact that the road was constructed, mechanically, or by continuous use as a public highway for a period of at least ten years, over public lands not reserved for public uses, prior to the earlier of (a) the October 21, 1976 repeal of R.S. 2477 or (b) the date the servient estate was reserved for public uses.
















Salt Wells Road - Box Elder County SGID RD_ID RD020044
