THE STATE OF UTAH

TO ALL WHOM THESE PRESENTS SHALL COME, Greeting:

Know ye, This is an Acknowledgment and Notice of Acknowledgment made under Utah Code Sections 72-5-309 through 310 inclusive, that the grant of the United States of America of “the right of way for the construction of highways over public lands, not reserved for public uses” under United States Revised Statutes 2477 (43 U.S.C. Section 932 (repealed October 21, 1976, with proviso recognizing the validity of rights-of-way already established)) was accepted for and on behalf of the State of Utah and its political subdivision Daggett County as it pertains to the highway located in Daggett County known as Pipeline Road Spur D; County Road Number: D26D; State Geographic Information Database (SGID) Road Identification Number: RD050063. Total road length is 0.8 miles more or less.

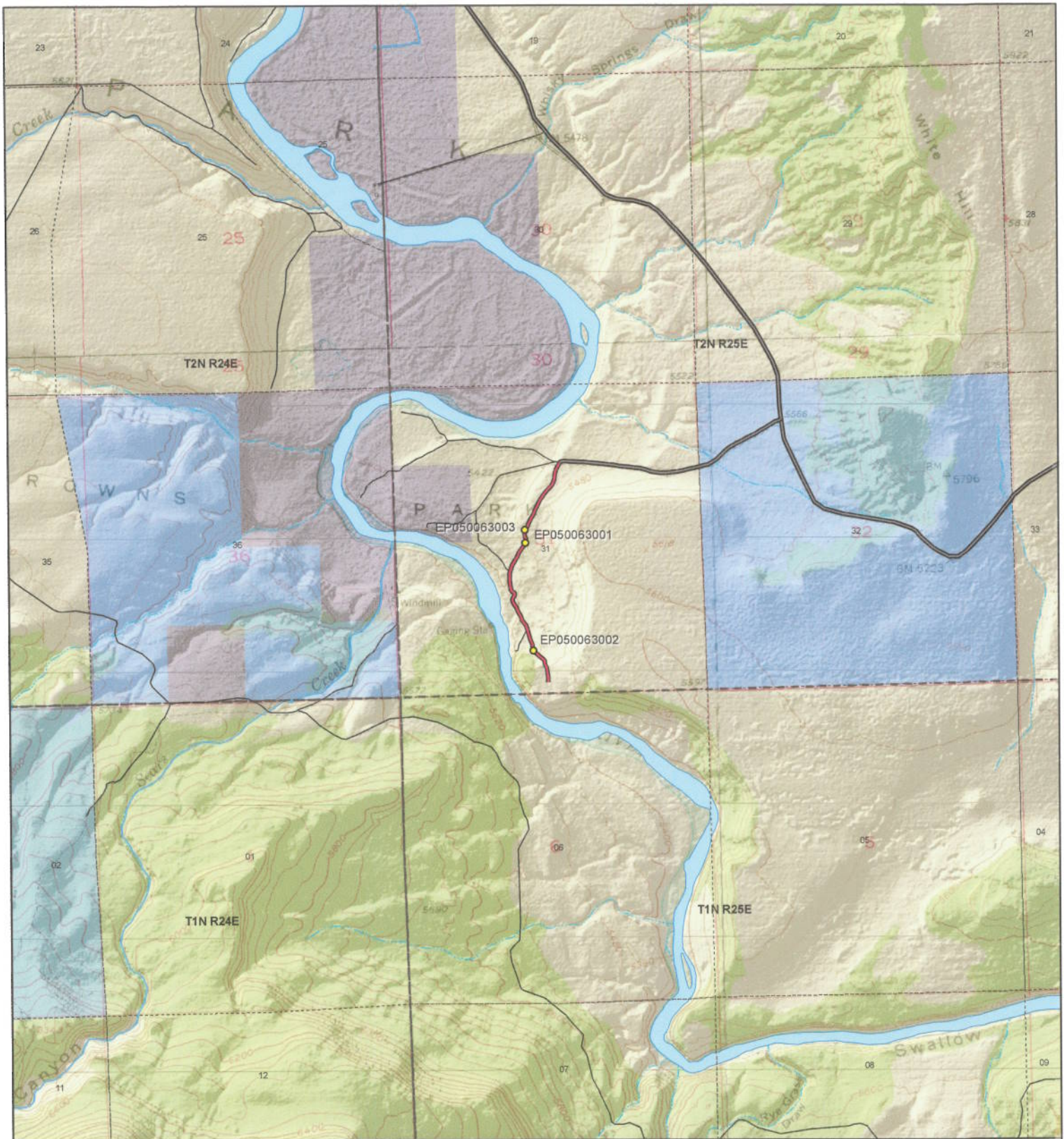
The reason for this Acknowledgment and Notice of Acknowledgment includes, but is not limited to, the fact that the road was constructed, mechanically, or by continuous use as a public highway for a period of at least ten years, over public lands not reserved for public uses, prior to the earlier of (a) the October 21, 1976 repeal of R.S. 2477 or (b) the date the servient estate was reserved for public uses.

This Acknowledgment and Notice of Acknowledgment applies only to the segments of the road that traverse land owned by the Bureau of Land Management, United States Department of the Interior, and does not apply to segments of the road that traverse land owned by any other person or entity. The State of Utah and its political subdivisions reserve the right to make further acknowledgments and notices of acknowledgment with regard to road segments that traverse land owned by other entities, including the United States of America, through one or more of its agencies.

A printed copy of a map showing the location of the road in said county is appended hereto as “Attachment 1,” a printed copy of representative photos of the road is appended hereto as “Attachment 2,” a printed copy of a description of the beginning and ending points of the entire road together with a list of Townships, Ranges and Sections that may be traversed by the road in said county is appended hereto as “Attachment 3,” and a printed copy of the Road Centerline Description Cover Page(s) is appended hereto as “Attachment 4.” The Appendices listed in “Attachment 4” that contain the actual road centerline descriptions are incorporated herein by reference. Affidavits provided by individuals familiar with the road are appended hereto as “Attachment 5.”

I, ELMER J. WIDIC, testify and declare under oath as follows:

1. I am an adult competent to testify about the matters set forth in this affidavit. My testimony is based upon my personal knowledge and experience. I was born in Green River, Wyoming on October 10, 1919 and I lived in the Three Corners area of Northeastern Utah, Southern Wyoming and Northwestern Colorado all of my life until 1982 when I moved to Riverdale, Utah where I currently reside. I began working as Field Foreman of the Clay Basin Field in 1965 for Mountain Fuel Supply Company, which operated a number of gas wells in the Clay Basin Field. I remained so employed until 1982. During this time period I lived in the Clay Basin and I was personally familiar with the construction and maintenance activities on the roads used for well service access in the Clay Basin Field.

2. I have traveled and am familiar with Pipeline Road Spur D, Daggett County Road D26D and the land it traverses.

3. I took the following steps to verify that the Pipeline Road Spur D I refer to in this affidavit and Daggett County Road D26D (the "Road") are the same road:

a. I examined a large Daggett County map depicting the Road in relation to other roads, intersections and landmarks. I observed the Road on the large map verifying that it is accurately depicted on the map and it is the Road I refer to herein.

b. I examined the map attached to this affidavit depicting the Road and surrounding area and verified that the Road is accurately depicted on the map and is the Road I refer to herein.

4. I personally traveled the Road from the late 1960s to the summer of 2008, (“the Time Period of My Experience”).

5. When I last traveled and observed the Road in 2008, it followed the same route as in the late 1960s, when I first traveled and observed it.

6. During the Time Period of My Experience the Road has been traveled weekly during the hunting, fishing and grazing seasons and less frequently during other times of the year. Based upon my observation during the Time Period of My Experience, the road was continuously used as a public thoroughfare by members of the public for public purposes whenever it was necessary and convenient for them to do so and I have never known the use of the road to have been interrupted by any means.

7. During the Time Period of My Experience I have personally traveled the Road by pickup truck and I have observed others from the general public use the Road by the same means.

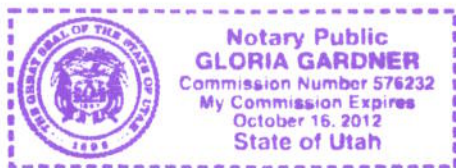
8. During the Time Period of My Experience I have personally used the Road for fishing, recreation and sightseeing and have observed livestock in the area.

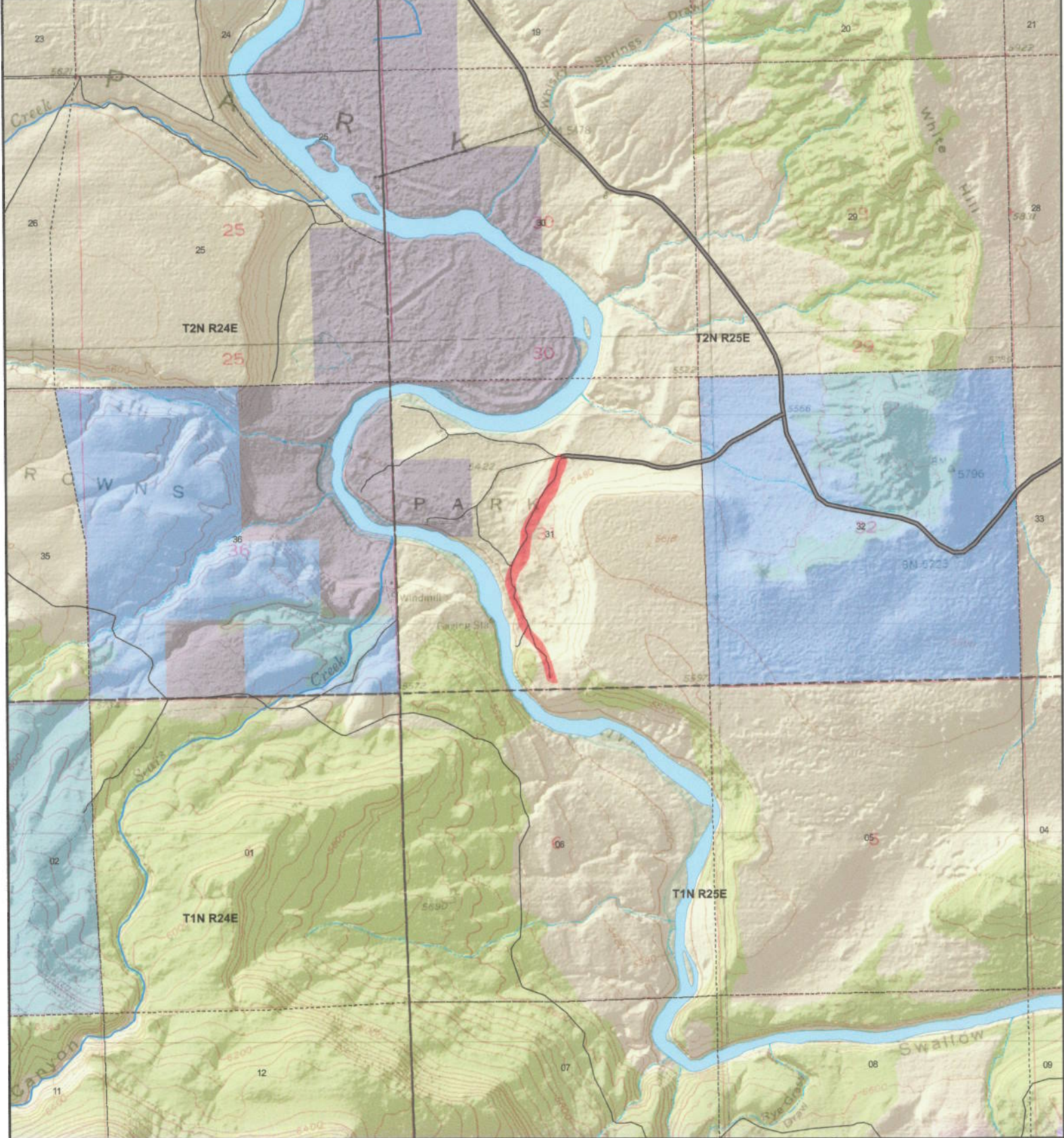



I, ALEX RADOSEVICH, testify and declare under oath as follows:

1. I am an adult competent to testify about the matters set forth in this affidavit. My testimony is based upon my personal knowledge and experience. I was born in Rock Springs, Wyoming on September 8, 1935, and have lived in the Three Corners area of Northeastern Utah, Southern Wyoming and Northwestern Colorado all of my life, and I currently live at the Willow Creek Ranch in Browns Park, Daggett County, Utah.

2. I have traveled and am familiar with Pipeline Road Spur D, Daggett County Road D26D and the land it traverses.

3. I took the following steps to verify that the Pipeline Road Spur D I refer to in this affidavit and Daggett County Road D26D (the " Road") are the same road:

a. I examined a large Daggett County map depicting the Road in relation to other roads, intersections and landmarks. I observed the Road on the large map verifying that it is accurately depicted on the map and it is the Road I refer to herein.

b. I examined the map attached to this affidavit depicting the Road and surrounding area and verified that the Road is accurately depicted on the map and is the Road I refer to herein.

c. I examined ground photos depicting the Road and surrounding area and verified that the Road is accurately depicted on the photos and is the Road I refer to herein.

4. I personally traveled the Road from the early 1950s through 1976 and continuing until 2008, (“the Time Period of My Experience”). It is the reputation in the community that the Road was traveled as early as the 1950s.

5. When I last traveled and observed the Road in 2008, it followed the same route as in the early 1950s, when I first traveled and observed it.

6. During the Time Period of My Experience the Road has been traveled daily. Based upon my observation during the Time Period of My Experience, the road was continuously used as a public thoroughfare by members of the public for public purposes whenever it was necessary and convenient for them to do so and I have never known the use of the road to have been interrupted by any means.

7. During the Time Period of My Experience I have personally traveled the Road by pickup and I have observed others from the general public travel the Road by the same means and cars and ATVs.

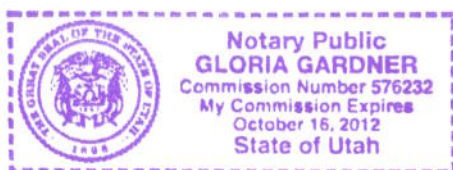
8. During the Time Period of My Experience I have personally used the Road for livestock operations and river access and I have observed others from the general public using the Road for the same purposes and fishing and camping access.

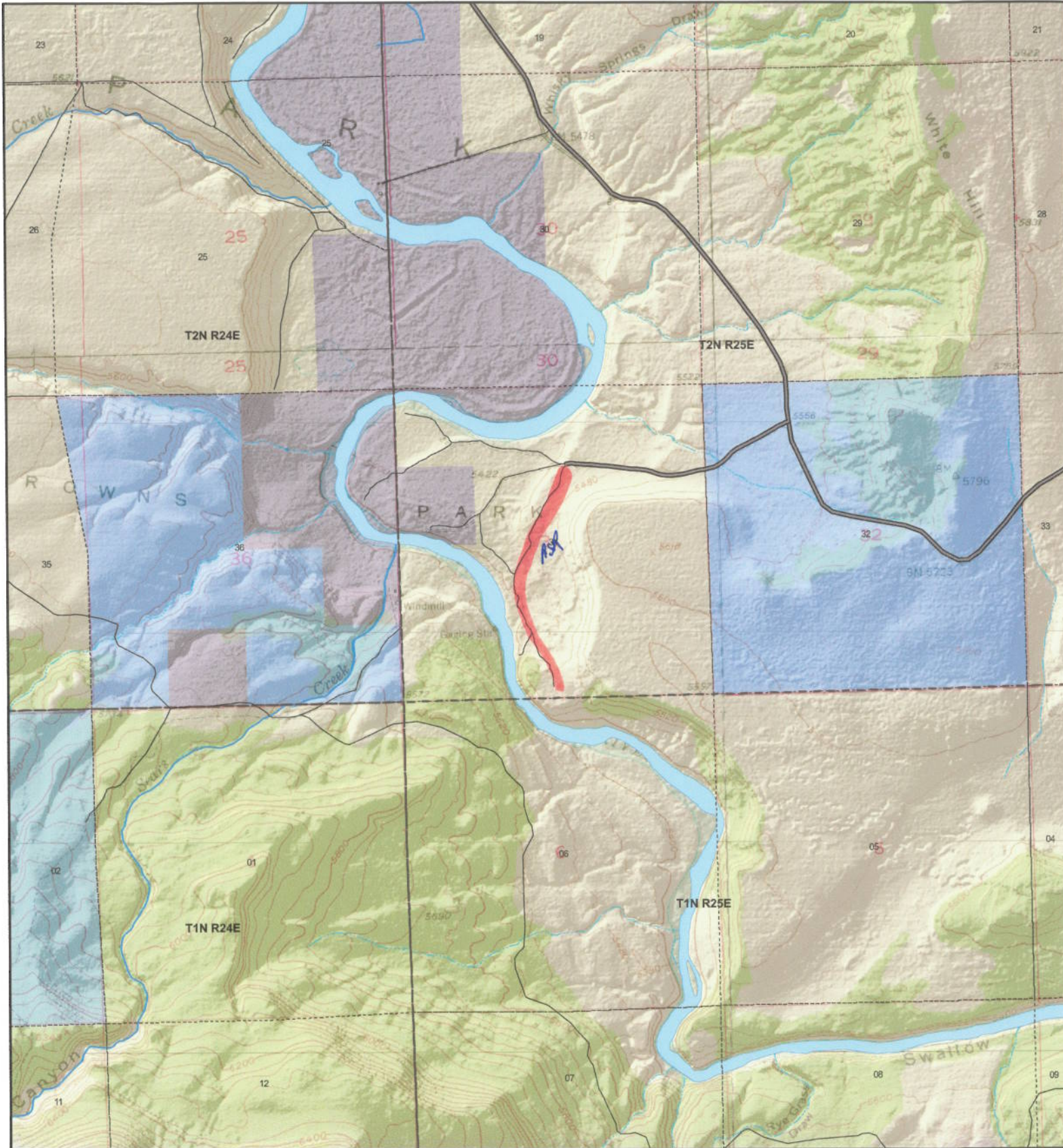

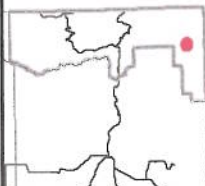

The following description is based upon the geographic coordinate system using the NAD83 Datum. The source is GPS mapping grade data as indicated in the metadata and/or the transportation data model of the State of Utah Geographic Information Database (SGID).

The road-segment itself is the monument that is identified by its physical presence on the land. The location of said physical presence is closely approximated by mapping grade Global Positioning System (GPS) data. Said data are checked against the corresponding gray-scale 1-meter Digital Orthophoto Quadrangles published by the United States Geological Survey (USGS) to verify a reasonable degree of accuracy. In circumstances where accurate satellite signal acquisition is not possible, such as deep, narrow canyons or under a canopy of dense foliage, or where very sharp curves in the road make accuracy questionable, such portions of the road were digitized from the corresponding gray-scale 1-meter Digital Orthophoto Quadrangles published by the United States Geological Survey (USGS).
