TO ALL WHOM THESE PRESENTS SHALL COME, Greeting:

Know ye, This is an Acknowledgment and Notice of Acknowledgment made under Utah Code § 72-5-309 through 310 inclusive that the grant of the United States of America of “the right of way for the construction of highways over public lands, not reserved for public uses” under United States Revised Statutes 2477 (43 U.S.C. § 932 (repealed October 21, 1976, with proviso recognizing the validity of rights-of-way already established)) was accepted for and on behalf of the State of Utah and its political subdivision Iron County as it pertains to the highway located in Iron County known as FREMONT CANYON ROAD; County Road Number: 21; State Geographic Information Database (SGID) Road Identification Number: RD110021. Total road length is 9.81 miles more or less.


The reasons for this acknowledgment are as follows (indicated by an “X” in one or more blocks and any supplemental comment):





Beginning at a point on the road centerline located at 38 degrees 07 minutes 46.41 seconds North Latitude and -112 degrees 37 minutes 33.94 seconds West Longitude, which can be converted to mapping accuracy State Plane Utah South Zone NAD 83 feet coordinates of X = 1,316,506.6 feet and Y = 10,377,124.4 feet based on the US Survey Foot conversion.

Ending at a point on the road centerline located at 38 degrees 05 minutes 15.59 seconds North Latitude and -112 degrees 28 minutes 43.44 seconds West Longitude, which can be converted to mapping accuracy State Plane Utah South Zone NAD 83 feet coordinates of X = 1,358,732.0 feet and Y = 10,361,392.0 feet based on the US Survey Foot conversion.
