THE STATE OF UTAH

TO ALL WHOM THESE PRESENTS SHALL COME, Greeting:

Know ye, This is an Acknowledgment and Notice of Acknowledgment made under Utah Code § 72-5-309 through 310 inclusive that the grant of the United States of America of “the right of way for the construction of highways over public lands, not reserved for public uses” under United States Revised Statutes 2477 (43 U.S.C. § 932 (repealed October 21, 1976, with proviso recognizing the validity of rights-of-way already established)) was accepted for and on behalf of the State of Utah and its political subdivision Uintah County as it pertains to the highway located in Uintah County known as Pete Canyon Road; County Road Number: 4420; State Geographic Information Database (SGID) Road Identification Number: RD242278. Total road length is 3.81 miles more or less.


The reasons for this acknowledgment are as follows (indicated by an “X” in one or more blocks and any supplemental comment):

- The road was laid out or erected for public use over public lands not reserved for public uses prior to the earlier of (a) the October 21, 1976 repeal of R.S. 2477 or (b) the date the servient estate was reserved for public uses;
- By reason of its continuous use as a public highway over public lands not reserved for public uses for a period of at least ten years prior to the earlier of (a) the October 21, 1976 repeal of R.S. 2477 or (b) the date the servient estate was reserved for public uses;

Beginning at a point on the road centerline located at 39 degrees 39 minutes 17.76 seconds North Latitude and -109 degrees 18 minutes 02.45 seconds West Longitude, which can be converted to mapping accuracy State Plane Utah Central Zone NAD 83 feet coordinates of X = 2,259,552.6 feet and Y = 7,050,648.9 feet based on the US Survey Foot conversion.

Ending at a point on the road centerline located at 39 degrees 41 minutes 48.58 seconds North Latitude and -109 degrees 17 minutes 05.93 seconds West Longitude, which can be converted to mapping accuracy State Plane Utah Central Zone NAD 83 feet coordinates of X = 2,263,594.3 feet and Y = 7,066,012.8 feet based on the US Survey Foot conversion.
