





1. I am an adult competent to testify about the matters set forth below based upon my personal knowledge. I currently reside in Uintah County, Utah. I have lived in Uintah County 79 years.

2. I have traveled and am familiar with a road in Uintah County known to me as the Wolf Den Road. I am also familiar with the land the road traverses. When I first used and observed the road in the 1950s, it followed the same route as in the 1970s when I last observed it. Attached is a Uintah County map showing Wolf Den. To the best of my knowledge and based upon my use of and familiarity with this road and the land it traverses, the location and route of the road are correctly illustrated on the attached map.

3. I am informed that the County identifies this road according to the road number described above.

4. I have observed that the road has been open to the public for all to use, to come and go as they pleased, since at least as early as the 1950s and continuing through 1976. During this time period I have observed travel on the road by various means, including trucks and jeeps. During this time period, the road has been used daily.

5. During the time period from the 1950s to the 1970s, I have used the road myself for hunting and recreation.

6. During the time period described in the previous paragraph, I observed vehicles using the road at various times for mining, wood gathering, traveling in and through the area and livestock operations.







To the best of my knowledge and based upon my use of and familiarity with this road and the land it traverses, the location and route of the road are correctly illustrated on the attached map.

3. I am informed that the County identifies this road according to the road number described above.

4. I have observed that the road has been open to the public for all to use, to come and go as they pleased, since at least as early as the 1950s and continuing through 1976 to 2006. During this time period I have observed travel on the road by various means, including trucks, jeeps and large 18-wheelers. During this time period, the road has been used daily.

5. During the time period from the early 1960s to 2006, I have used the road myself for livestock operations, hunting, oil and gas exploration or development, recreation and wood gathering.

6. During the time period described in the previous paragraph, I observed vehicles using the road at various times for oil and gas exploration or development, mining, prospecting for minerals, wood gathering, traveling in and through the area, recreation, livestock operations, other commerce, hunting and government access.




