I, CLYDE R. NAYLOR, being first sworn, deposes and states as follows:

- I am an adult competent to testify about the matters set forth below based on my personal knowledge.
- My educational background includes a B.E.S. degree in Civil Engineering and M.S. degree in Structural Engineering, both from Brigham Young University.
- 3. I am currently a member of the American Public Works Association where I was the past chapter president and a past National Institute for Transportation Executive Council Member, a member of the American Society of Civil Engineers, and a member of the Utah Council of Land Surveyors.
- 4. I have been the Utah County Surveyor from January 1979 to December 31, 2006, the Utah County Engineer from January 1980 to the present, and the Utah County Public Works Director from January 1991 to the present. During these time periods, I have been personally familiar with Utah County's construction and maintenance activities on county roads, including the "B"road know as the Twelve Mile Pass Road that runs from 18150 West Street to Tooele County. A map of the road is attached hereto as Exhibit "A".

- 5. The road is known as Utah County "B" road # B 978. The road is a dirt road located in Township 8 South, Range 3 West. The 0.90 miles length of the road, located in Sections 26 and 36 of Township 8 South, Range 3 West runs across federal property.
- 6. As the Utah County Surveyor, I have supervised a center line survey of the segments of the Twelve Mile Pass Road believed to be in the ownership of the Bureau of Land Management.

The center line descriptions are as follows:

## SEGMENT 1:

Commencing at the point of intersection of the centerline of the Twelve Mile Pass Road with the North-South One-Sixteenth line of the Southeast Quarter of Section 26,

Township 8 South, Range 3 West, Salt Lake Base and Meridian, said point of intersection being more specifically described as being located 7,860.30 feet North and 6,571.31 feet

West from the Southeast Corner of Section 36 of said Township and Range; thence the following along said centerline: South 87° 47' 06" West 88.46 feet; South 82° 08' 16"

West 130.35 feet; North 84° 07' 22" West 49.32 feet; North 63° 59' 36" West 57.86 feet; North 51° 24' 21" West 239.56 feet; North 41° 45' 59" West 150.46 feet; North 48° 02'

42" West 55.31 feet; North 61° 09' 49" West 109.11 feet; North 65° 59' 37" West 212.93 feet; North 62° 22' 26" West 132.98 feet; North 66° 09' 57" West 110.37 feet; North 77°

05' 55" West 197.66 feet; North 69° 20' 24" West 252.36 feet; North 64° 36' 44" West 429.64 feet; North 67° 37' 38" West 134.22 feet; North 64° 15' 10" West 300.31 feet;

North 67° 31' 05" West 97.56 feet; North 61° 37' 38" West 186.86 feet; North 64° 54' 12" West 221.52 feet; North 70° 47' 18" West 291.51 feet; North 65° 34' 45" West 101.90 feet; North 58° 32' 57" West 56.69 feet; North 53° 15' 44" West 124.15 feet; North 58° 40' 27" West 122.16 feet; North 62° 38' 53" West 365.96 feet; North 59° 09' 13" West, 359.66 feet.

## SEGMENT 3:

Commencing at the point of intersection of the centerline of the Twelve Mile Pass Road with the North line of Section 36, Township 8 South, Range 3 West, Salt Lake Base and Meridian, said point of intersection being more specifically described as being located 5,381.36 feet North and 3,068.07 feet West from the Southeast Corner of Section 36 of said Township and Range; thence the following along said centerline: South 31° 31' 21" East 54.73 feet; South 43° 36' 10" East 31.39 feet; South 59° 06' 03" East 28.96 feet; South 72° 33' 21" East 186.87 feet; South 68° 39' 22" East 96.23 feet; South 65° 05' 33" East 123.92 feet to the approximate North-South One-Quarter Section line.

- 7. Pursuant to Utah Code Ann. § 17-23-1 and during the time I served as the Utah County Surveyor, I was the designated record holder for all the surveys and maps made within the county. The records of the Utah County Surveyor show that the road has existed since 1949, and has been utilized and maintained as a county "B" road since that time. The attached copies of documents taken from the Utah County Surveyor's records identify the roads existence:
  - a. The United States Government survey map for Boulter Mts., Utah dated
     1949, shows the location of the road in Sections 26 and 36 of Township 8

- South, Range 3 West, which is attached hereto as Exhibit "A1".
- b. The general highway map of Utah County, dated 1975, prepared by the Utah State Department of Highways, shows the Twelve Mile Pass Road as a county road that runs from the 18150 West Street to Tooele County, which is attached hereto as Exhibit "A2".
- c. The general highway map of Utah County prepared by the Utah Department of Transportation, dated 1985, shows the county road, which is attached as Exhibit "A3".
- d. The Road Map of Utah County, Sheet # 8, created November 21, 1995, shows the relationship the road has with the federal property in the area, which is attached as Exhibit "A4".
- e. The official County Road Map of Utah County, Sheet #8, adopted by the Board of County Commissioners on October 30, 1996, shows the road running across the federal properties, which is attached as Exhibit "A5".
- f. The current County Atlas, page 10, titled Allens Ranch, shows the Twelve

  Mile Pass Road as it traverses federal property, which is attached as

  Exhibit "A6".
- g. The surveyed description for Segment 01 of the Twelve Mile Pass Road has been plotted on an Aerial Photo taken in 1993 to verify the roads existence and is attached as Exhibit "A7".

- h. The surveyed description for Segment 03 of the Twelve Mile Pass Road has been plotted on an Aerial Photo taken in 1993 to verify the roads existence and is attached as Exhibit "A8".
- 8. At no time during my tenure with the County did it undertake any procedure to abandon or vacate its right-of-way on the road.
- I have had the County records searched for any evidence of reservations on this road and none have been found.



- I, ROBERT CURTIS BEVERLY, being first duly sworn, deposes and state as follows:
  - I am an adult competent to testify about the matters set forth below based on my personal knowledge.
  - 2. From 1958 to 1988, I was employed with Utah County in the Roads Department where I was an operator/truck driver, supervisor over bridges and culverts, and worked in maintenance and oiling of roads. During that time period, I was personally familiar with Utah County's construction and maintenance activities on county roads, including the road known as Twelve Mile Pass Road that runs from 18150 West Street to Tooele County. A map of the road is attached hereto as Exhibit "A".
  - 3. Construction and maintenance of the road before 1949 was performed by graders, dozers, and other road equipment in addition to the passing of motorized vehicles over the roadway. For several years after 1949, during the 1950's, 1960's, and 1970's, I helped maintain the road using graders and other road equipment.
  - 4. All acts of the County regarding this road were, to my knowledge, consistent with its status as a public highway.
  - 5. I am familiar with the indicated road because I worked for the Utah County Public Works Department Roads Division for several years beginning in 1949;
    one of my responsibilities was the maintenance of Twelve Mile Pass Road.
  - 6. Since before 1949 and continuing to the present the road has been used for ranching, hunting, homesteading, commerce, sightseeing, camping, recreation, and traveling in and through the area. At least as early as 1949, I often used the road for hunting and while working for the county.

- 7. The road has been open to the public for all to use, to come and go as they pleased, since before 1949 and continuing through 1976 and beyond.
- 8. Travelers on the road from before 1949 and continuing thereafter included car, recreational vehicle, and truck. The frequency of use over the period 1966 to the present is approximately daily during the hunting season and the spring and summer months.
- When I first used and observed the road it ran the same route as it does now, and the road was well established as of 1949.
- 10. At no time during my employment with the County did it undertake any procedures to abandon or vacate its right-of-way on the road.



I, BYRON L. ORTON, being of first duly sworn, deposes and state as follows:

- I am an adult competent to testify about the matters set forth below based on my personal knowledge.
- 2. From 1947 to 1965 I was employed with the Utah Department of Transportation in District 6 where I was a truck operator, a foremen, and supervisor. From 1965 to 1985 I was employed with Utah County in the Roads Department where I was an assistant supervisor and supervisor over the Roads Department. During that time period, I was personally familiar with Utah County's construction and maintenance activities on county roads, including the road known as Twelve Mile Pass Road that runs from the 18150 West Street to Tooele County. A map of the road is attached hereto as Exhibit "A".
- Construction and maintenance of the road before 1965 was performed by hand labor and by road graders and other road equipment in addition to the passing of motorized vehicles over the roadway.
- All acts of the County regarding this road where, to my knowledge, consistent with its status as a public highway.
- 5. The road has been open to the public for all to use, to come and go as they pleased, since before 1965 and continuing through 1976 and beyond.
- 6. Since before 1965 and continuing to the present the road has been used for ranching, farming, hunting, commerce, camping, recreation, law enforcement, and traveling in and through the area. Between 1965 and 1985 I often traveled the road in order to perform inspections and regular maintenance.
- 7. Travelers on the road from before 1966 and continuing thereafter included those who went

by car, recreational vehicle, and truck. The frequency of use over the period 1966 to the present is approximately daily except during the winter when the road travel is light.

- 8. When I first used and observed the road it ran the same route as it does now, and the road was well established as of 1965.
- At no time during my employment with the County did it undertake any procedure to abandon or vacate its right-of-way on the road.


